Sample of Cemetery By-laws

Please find full description of By-Laws (Cemetery BY-LAW NUMBER 2018-44) included here below online or at your request. Plans and Maps showing all lots available for purchase within all municipally owned and operated cemeteries are retained within the Cemetery Department

All interments in lots shall be restricted to the rights holder or on written direction of the Interment Rights Certificate Holder.

No interment shall be made without the written order of the owner of the lot, their executor(s) or trustee(s).

When a lot is held jointly by two or more persons, a written direction will be accepted from either or any of them or their authorized representatives for interment in such part of the lot as may be requested.

In those circumstances where the party requesting the interment activity is unable to provide evidence of ownership, the party may be requested; to submit verifiable proof of ownership acceptable to the Cemetery Agent.

A burial permit issued by the Division Registrar or Deputy, showing the death has been registered and the prescribed fee for this service according to the Price List must be deposited with the Cemetery Agent before interment can take place.

In the case of a cremated remains interment, the Certificate of Cremation and the prescribed fee for this service according to the Price List must be deposited with an agent of the Corporation.

Interment Periods and Normal Working Hours (time periods when interments may be conducted)

Normal Working Hours: 9:00 a.m. to 3:00 p.m.

Monday to Friday excluding statutory or other municipally observed holidays.

Exceptions: where warranted by a medical certificate pertaining to the control of a communicable disease; religious practices; at the discretion of a Cemetery Agent should circumstances warrant.

Additional Fees: all interments that take place outside of normal working hours will be subject to additional fees at the rate prescribed in the current price list.

No planting of trees or shrubs shall take place without the written permission of the Cemetery Agent. All trees and shrubs must be ornamental and must not exceed four feet in height. Once planted the trees or shrubs become property of the cemetery and may be removed, without notice if deemed necessary by the Cemetery Agent.

Only flat or pillow markers may be placed on cremation or infant graves.

No upright monuments are allowed in the Locks Cemetery due to soil, ground conditions.

No monument or marker shall encroach on any grave space.

Options for payment: by phone 705-789-1751 (opt. 2) with a finance clerk, using the **Cemeteries Online Payment Form**, or in person at the third floor of Town Hall. The Town Cemeteries do not accept installments or deposits for services.
