**PURPOSE AND EFFECT:** The application has been made for the creation of one urban mixed-use lot. The severed lot would have an area of approximately 9,683m<sup>2</sup> with 88m of frontage on Shay Road. The retained lot would have an area of approximately 11,949m<sup>2</sup> with 92m of frontage on Shay Road and 135m of frontage on Ott Drive.



A decision on this application will be made **NO EARLIER THAN Thursday, October 9<sup>th</sup>, 2025.** Any submissions regarding this application must be made in writing before this date.

**IF YOU WISH TO BE NOTIFIED** of the decision of the Town of Huntsville in respect of the proposed consent, you must make a written request to the Planning Department (see address below).

**IF AN INDIVIDUAL, SPECIFIED PERSON OR PUBLIC BODY** files an appeal of a decision of the Town of Huntsville in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Town of Huntsville before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.
