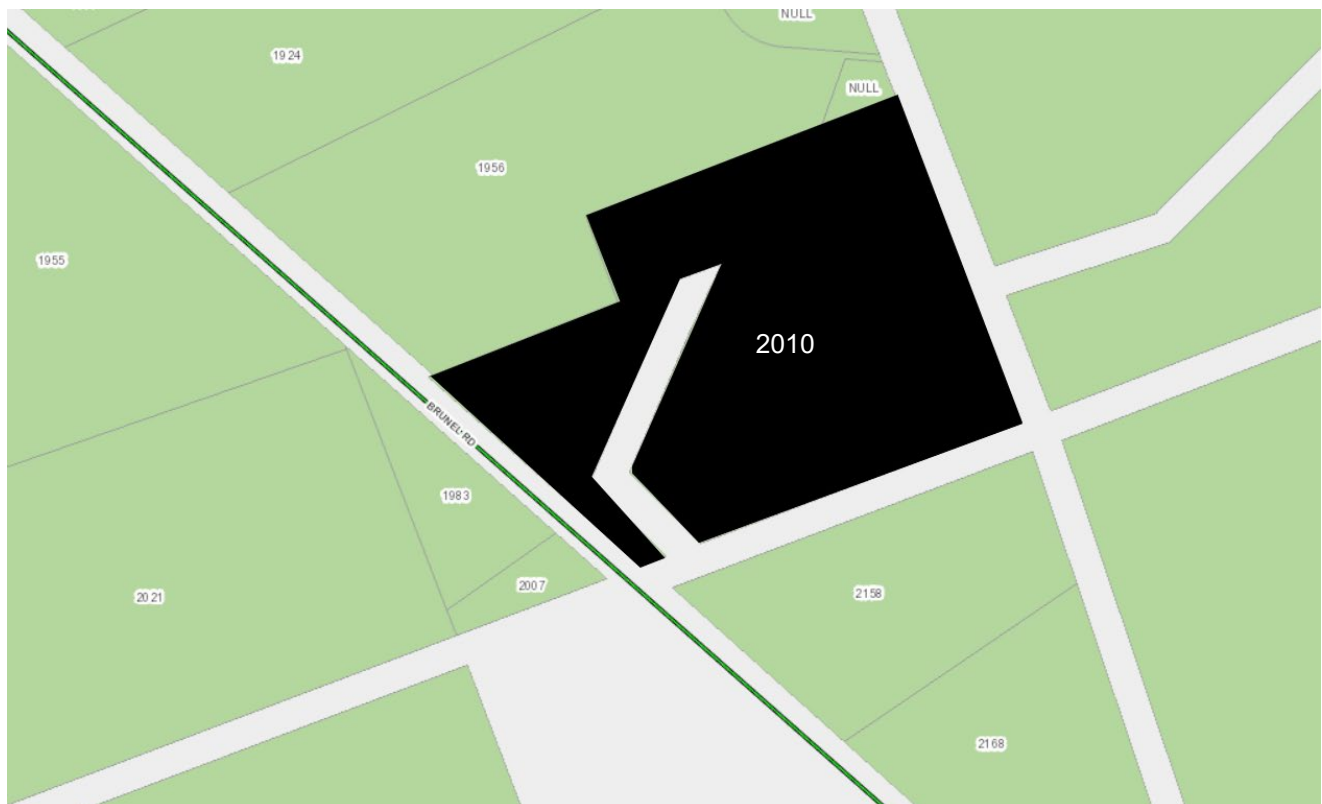

LEGAL DESCRIPTION: Part of Lot 15, Concession 7; Former Township of Brunel; Parts 1, 2 & 3 on 35R-7721; And Parts 1 & 2 on 35R-7721; Town of Huntsville

PURPOSE AND EFFECT: The applicant is proposing the development of a tourist camping establishment. The amendment is proposed to change the precinct on the lands from a Rural (RU) precinct to a Rural with Exception (RU-Exception) precinct to permit a Tourist Camping Establishment with a maximum of thirty-nine (39) accessory buildings or structures including thirty (30) camping structures, a kitchen building, a clubhouse building with one (1) dwelling unit, two (2) spa buildings, two (2) saunas, a yoga pavilion and a staff accommodation building, as well as permit development within 3m of the road allowance. The amendment also proposes to remove Previous Zoning Exception RU1-0049 from applying to the lands.



Members of the public wishing to provide comment are strongly encouraged to make a written submission prior to the meeting by emailing planning@huntsville.ca, or via mail. Members of the public wishing to make oral submissions to Council may do so during the meeting. Members of the public wishing to attend this meeting virtually are asked to review the disclaimer respecting virtual meeting participation at www.huntsville.ca/PC and consider in person attendance where possible to avoid technical issues that may arise. IF YOU WISH TO BE NOTIFIED of the decision of Council on the proposed community planning permit by-law amendment, you must make a written request to the Town of Huntsville (see address below).

IF A PERSON OR PUBLIC BODY would otherwise have an ability to appeal the decision of Council to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to Planning Council before the by-law is passed, the person or public body is not entitled to appeal the decision. If a person or public body does not make oral submissions at a public meeting, or make written submissions to Planning Council before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
