





### Deadline for filing Application

Subsection 88.33 (3) of the *Municipal Elections Act, 1996*, (Act) provides that the Application must be made within 90 days after the latest of the following dates:

1. The filing date under section 88.30 - **June 29, 2023** would be the last day to file a compliance audit request for the December 31, 2022 reporting period (regular campaign period filing deadline is 2:00 p.m. on March 31, 2023).
2. **The date the candidate paid a \$500 late filing fee and filed a financial statement** if the statement was filed within 30 days after the applicable filing date under section 88.30 for the December 31, 2022 reporting period (regular campaign period late filing deadline is 2:00 p.m. on May 1, 2023).  
  
i.e. If a candidate filed their financial statement on April 5, 2023, the deadline to file a Compliance Audit Application would be 90 days from that date, being July 4, 2023. If the candidate filed on the 30<sup>th</sup> day, May 1, 2023, the deadline to file a compliance audit application would be 90 days from that date, being July 31, 2023.
3. The candidate's supplementary filing date, if any, under section 88.30 – September 29, 2023 would be the last day to file a compliance audit request for the June 30, 2023 supplementary reporting period (supplementary campaign period filing deadline is 2:00 p.m. on December 29, 2023, being 90 days from filing deadline of September 29, 2023).
4. The date on which the candidate's extension, if any, under subsection 88.23 (6) expires – court granted extension.

Distribution of this Application will be shared with the Clerk of the Member Municipality, the Muskoka Compliance Audit Committee, the Auditor chosen to investigate this Application (if applicable), the Candidate, and the public by way of an open Muskoka Compliance Audit Committee meeting agenda published on the website of the Member Municipality.
