



REQUEST FOR COMMENTS COMMUNITY PLANNING PERMIT APPLICATION

TAKE NOTICE that the Town of Huntsville has received an application for a Class 3 Community Planning Permit. To facilitate the development proposed, a Class 3 Variation is needed from one or more of the applicable requirements of the Town of Huntsville Community Planning Permit By-law (By-law 2022-97, as amended).

LEGAL DESCRIPTION: Part of Lot 27-28, Concession 8; Former Geographic Township of Stisted; designated as Part 1 of Plan 35R-23223; Town of Huntsville; District Municipality of Muskoka

PURPOSE AND EFFECT: The applicant proposes to construct a 95.1m² detached garage, and a 79.5m² dock. A Class 3 – Council Variation is required to:

- Increase the maximum permitted Shoreline Activity Area width from 15m to 41.5m to recognize existing approvals and allow for a shed and the proposed dock;
- Increase the maximum permitted dock projection in a narrow waterbody from 6m to 14.9m to recognize the existing approved dock and allow a 3.6m extension; and
- Increase the maximum number of permitted roofed accessory structures from four (4) to eight (8) to recognize existing structures and permit the proposed garage.
